Question 10 – Extract Based (Any Two) (8 marks)

- A. "Instead of the cross, the Albatross / About my neck was hung." The Rime of the Ancient Mariner
- i. He had shot the Albatross without reason, destroying the bird that had brought wind and hope to the crew. (1)
- ii. The Albatross comes to symbolize the Mariner's sin against Nature and his burden of guilt for defying the natural order. (1)
- iii. The replacement of the Christian cross with the Albatross shows spiritual reversal his sin has become his new 'cross to bear.' (1)
- iv. This moment marks the start of his penitence and long path to redemption through suffering and spiritual awakening. (1)
- B. "Louisa Mebbin's pretty week-end cottage, christened by her 'Les Fauves,' and gay in summer-time with its garden borders of tiger-lilies, is the wonder and admiration of her friends." Mrs. Packletide's Tiger
- i. The name 'Les Fauves' ('The Wild Beasts') ironically refers to the tiger Mrs. Packletide shot and to Mebb in's predatory greed that benefited from it. (1)
- ii. She bought the cottage with the money she blackmailed from Mrs. Packletide after the failed tiger hunt. (1)
- iii. Tiger-lilies in her garden mock the event since they symbolically derive from the tiger episode that finan ced her luxurious life. (1)
- iv. These details expose Louisa Mebbin as cynical, calculating, and morally self-serving; she profits from ot hers' vanity without scruples. (1)
- C. "So, till the judgment that yourself arise, / You live in this, and dwell in lovers' eyes." Nor Marble, nor the Gilded Monuments (Sonnet 55)
- i. The poem itself—its verse and the memory of the beloved—will endure after monuments perish. (1)
- ii. "Lovers' eyes" stand for human admiration and affection that keep the beloved alive in memory. (1)
- iii. The couplet asserts that poetry has immortalizing power greater than time or decay. (1)
- iv. It shows Shakespeare's faith that artistic expression grants permanent renown—an eternal legacy of love and art. (1)

- i Two Gentlemen of Verona— The revelation that the boys toil to support their ailing sister 2 marks Lucia changes the narrator's view from pity to admiration; he sees true gentility in their devotion and sacrifice.
- ii Mrs. Packletide's Tiger– She desired fame for shooting a tiger, but it dies naturally; 2 marks irony lies in the fact that false glory and deception replace actual bravery.

- iii The Letter— Whenever the postmaster waits for news from his own daughter, he feels
  Ali's pain and develops sympathy; this spiritual awakening humanizes him.
- iv The Frog and the Nightingale—The frog flattered the nightingale, made her sing for money, criticized her style, and over-trained her until she died; he used manipulation for self-gain.
- v Snake—The poet acts on 'voices of education' and throws a log at the snake; he later regrets his cowardice and realizes he offended nature's innocence.
- vi The Rime of the Ancient Mariner—The shooting symbolizes humankind's disrespect for 2 marks Nature and a moral spiritual fall; it sets the stage for punishment and atonement.

#### Q.12. Answer any one of the following two questions in about 150 words. 1x8=8

Option A – Virtually True

The story merges technology and emotion through Michael's discovery of Sebastian Shultz within virtual-reality games. Each level—Wild West, Dragon Quest, Jail Break—reveals Sebastian's trapped consciousness. Michael's determination to rescue him shows friendship, empat hy, and belief that digital worlds can foster real human connection. The story suggests technology is ethical and meaningful only when it strengthens human values.

## Option B - A Shady Plot & Julius Caesar

Both A Shady Plot and Julius Caesar use supernatural interventions to dramatize the inner conflicts of characters, elevating fear, conscience, and guilt that shape the plot.

In A Shady Plot:

The ghost of Helen symbolizes Hallock's creative guilt and fear. It confronts him about his reliance on supernatural inspiration, stirring his conscience. The ghost's presence manifests Hallock's struggle between fear of failure and desire for success, making his inner conflict external and visible. This supernatural encounter pushes Hallock toward self-awareness and resolution, thus driving the story forward.

In Julius Caesar (focusing on Caesar's wife Calpurnia and the Guards):

Calpurnia experiences eerie nightmares and visions forewarning Caesar's impending death, heightening her anxiety and sense of guilt about not convincing Caesar to stay home. The guards (or sentinels) witness unnatural omens like strange noises and ghostly sights on the night before Caesar's assassination, which increase collective fear and foreboding. These supernatural signs intensify the characters' internal anxieties, reflecting their rising guilt and moral conflict over Caesar's fate. Through these omens, Shakespeare externalizes the tension and fear that underpin the tragic unfolding, preparing the audience for the critical turning point.

## Comparison:

Both texts use ghosts and omens as tangible expressions of invisible guilt and conscience.

A Shady Plot centers personal artistic fear and guilt via Helen's ghost; Julius Caesar universalizes politica
anxiety through supernatural warnings to Calpurnia and the guards. In both, the supernatural heighten
emotional states, making internal struggles undeniable and compelling action or realization. Together, these
interventions deepen character complexity and propel the narrative by making fear and guilt unavoidable
forces shaping decisions and outcomes.
