Answer: Partition brought devastating consequences for the people of India and Pakistan:

- i. Mass Migration: About 80 lakh people crossed borders, often leaving behind everything they owned. ii. Communal Violence: Between 5–10 lakh people were killed. Horrific acts of violence occurred on both sides, with mass killings, rapes, and abductions.
- iii. Division of Resources: Financial assets, government institutions, railways, and even musical instruments had to be divided between India and Pakistan.
- iv. Minorities Issue: Huge questions arose about the safety, rights, and treatment of minorities in both countries.
- Q21. Explain the factors that helped the Congress Party to dominate Indian politics after independence. 4 Ans: The Congress Party dominated Indian politics after independence because:
- i. It led the freedom struggle, so it had huge public trust and support.
- ii. It had a strong organization across all parts of India.
- iii. Congress leaders like Jawaharlal Nehru were very popular and visionary.
- iv. After independence, Congress was seen as the party that would unite and develop India.

How was tolerance and internal democracy maintained within the Congress Party?

Ans: Tolerance and internal democracy were maintained in Congress because:

- ii. Different opinions were respected, and decisions were taken through dialogue.

- iv. This helped the Congress Party adjust to people's demands and prevented dictatorship inside the party.

Answer: The Second Five-Year Plan (1956–1961), drafted under P.C. Mahalanobis, had the following characteristics:

- i. Focused on industrialization and the development of infrastructure.
- ii. Leaned towards a socialist economic pattern.

- iii. Imposed high tariffs on imports to protect domestic industries.
- iv. Gave major industries like electricity, steel, and railways under public sector control.

Provide a short overview of NITI Aayog.

Answer: The National Institution for Transforming India (NITI Aayog) acts as a policy think tank of the Government of India. It was set up to provide strategic and technical advice on major policy matters and to promote cooperative federalism among states. NITI Aayog was established after replacing the Planning Commission on January 1, 2015. It is headed by the Prime Minister, and its governing body includes all Chief Ministers and Union Territory administrators. At present, Suman Bery is the Vice-Chairman, and Parameswaran Iyer serves as the CEO.

further damage to the global environment. How could we achieve this? Explain with a few examples. 6 Answer-

The economic development can be achieved even without damaging the global environment through various measures:

- In June 1992, Earth Summit provided some conservative measures for sustainable growth without damaging the environment anymore.
- There have been many path-breaking agreements such as the 1959 Antarctic Treaty, the 1987 Montreal Protocol, and the 1991 Antarctic Environmental Protocol.
- Kyoto protocol cut greenhouse emissions from industrialized countries to protect the environment and to develop industries also.
- The purification, consumption, reuse, disposal and treatment of solid waste should be undertaken by the government.

OR

Define resource geopolitics and explain why oil and water are becoming sources of conflict.

Answer: i. Resource geopolitics deals with who controls and accesses natural resources, like oil and water.

- ii. Oil is crucial for industrial growth; most reserves are in West Asia (e.g., Saudi Arabia, Iraq).
- iii. Powerful nations maintain control through military presence and economic influence.
- iv. Water scarcity is increasing disputes over shared rivers (e.g., between Turkey, Syria, and Iraq).
- v. Countries use force, diplomacy, and international pressure to protect access.
- vi With growing demand and limited supply, resource conflicts may increase in the future.

Q28. Discuss the major issue which led to the formal split of the Congress Party in 1969.

Answer:

The formal split in Congress took place in 1969 on the issue of nomination of the candidate during presidential elections:

- Despite, Indira Gandhi's reservations, the Syndicate nominated Neelam Sanjeeva Reddy, as the official Congress candidate for ensuing Presidential elections.
- Indira Gandhi retaliated the situation by encouraging Mr. V.V. Giri, the then Vice-President, to be nominated as an independent candidate.
- During election, the then Congress President S. Nijalingappa issued a whip asking all Congress MPs. MLAs to vote for N. Sanjeeva Reddy.
- On the other hand, after silently supporting V.V. Giri, the Prime Minister Mrs Indira Gandhi openly called for a conscience vote to vote the way they want.
- Elections went in favour of V.V. Giri due to this diplomatic effort and N. Sanjeeva Reddy was defeated. This led to formal split in the congress.

OR

How did Indira Gandhi's leadership style differ from earlier Congress leaders? Give examples from her early tenure.

Answer:

- i. Earlier Congress leadership was collective and consultative, especially under Nehru.
- ii. Indira Gandhi adopted a centralised and personalised leadership style.
- iii.Indira Gandhi bypassed the Syndicate and made bold decisions like: Nationalisation of banks
- Abolition of Privy Purse Supporting V.V. Giri over the party's official presidential nominee
- iv. Her slogan "Garibi Hatao" was directly addressed to the poor, unlike earlier abstract campaigns.
- v. After her 1971 victory, she became the sole decision-maker in the party and government.
- vi. Indira Gandhi's style strengthened her popularity but also weakened internal democracy in the party.

Q29. Examine how the Indian government dealt with regional aspirations through democratic means in different states. Give suitable examples.

Ans- i. India addressed regional demands through democratic negotiations rather than force.

- ii. The Rajiv Gandhi–Longowal Accord (1985) in Punjab met Sikh demands, the Mizo Accord (1986) ended two decades of insurgency with statehood and special powers, and the Assam Accord (1985) resolved illegal immigration issues.
- iii. These cases show that dialogue, power-sharing, and accommodation are more effective for maintaining national unity and peace.
- iv. The creation of new states like Chhattisgarh, Jharkhand, and Uttarakhand in 2000 reflected the government's willingness to respect regional identities through peaceful constitutional methods.

v. The implementation of the Sixth Schedule in tribal areas of Northeast India granted autonomy to local communities through Autonomous District Councils, recognizing their cultural and political rights. vi. The resolution of the Gorkhaland movement through the formation of the Gorkhaland Territorial Administration (GTA) in 2011 is another example of devolving power to address regional aspirations within a democratic framework.

OR

Regional demands from different parts of India exemplify the principle of unity with diversity. Do you agree? Give reasons.

Answer: Yes, we agree with the statement because India adopted a democratic approach on these regional aspirations in place of considering them as anti-national:

- 1. India's democratic politics allows people and groups to address the people on the basis of their regional identity, aspiration, and specific regional problems.
- 2. India's democratic politics focus on regional issues and problems to receive adequate attention and accommodation in the policy making process, i.e. regional aspirations of Assam, Punjab and North-East, Kashmir etc.
- 3. Its examples are in eighties, military erupted in Punjab, problems persisted in the North-East, students agitated in Assam and Kashmir valley was on the boil.
- 4. The government of India settled down some negotiations with these regional aspirations to reduce tensions in many regions.
- 5. Mizoram is an example of political settlement to resolve the problem of separation effectively. It can be concluded that regional aspirations do not encourage separation but these respect diversity to retain unity in the nation.
- Q30. How did the rise of BJP and the Ram Janmabhoomi movement change the nature of secular politics in India?

Ans: i. The BJP, formed in 1980 after the Janata Party split, initially promoted Gandhian Socialism but saw limited success.

- ii. From 1986, it embraced Hindutva, defining Indian nationhood through Hindu identity, with the Ram Janmabhoomi movement at its core.
- iii. Key moments included the Shah Bano case (1985), which the BJP called "minority appearement," the unlocking of Babri Masjid (1986), L.K. Advani's Rath Yatra, the 1992 Babri Masjid demolition, and the 2002 Gujarat riots after the Godhra incident.
- iv. These developments fueled communal violence, voter polarisation, and a shift from secularism toward majoritarian identity politics, challenging India's secular framework and reshaping democratic values.
- v. The movement blurred the lines between religion and politics, influencing public discourse and policy decisions, and prompting other parties to adopt soft Hindutva or recalibrate their secular stance to remain electorally competitive.
- vi. It also led to the judiciary and state institutions being increasingly drawn into religious-political controversies, raising concerns about institutional impartiality and the erosion of secular governance.

OR

State the main issues in Indian politics in the period after 1989. What different configurations of political parties these differences lead to?

Answer:

- i. Defeat of the Congress party: Congress lost in the elections held in 1989. The Congress came back to power soon after the mid-term elections held in 1991. But the elections of 1989 marked the end of what political scientists have called the 'Congress system'. The Congress remained an important party but it lost the kind of centrality it earlier enjoyed in the party system.
- ii. Mandal issues: The new National Front government in 1990 implement the recommendation of the Mandal Commission that jobs in central government should be reserved for the Other Backward Classes. The dispute between the supporters and opponents of OBC reservations played an important role in shaping politics since 1989.
- iii. Economic Policy: This is known as the initiation of the structural adjustment programme or the new economic reforms. Started by Rajiv Gandhi, these changes first became very visible in 1991 and radically changed the direction that the Indian economy had pursued since Independence.
- iv. Demolition of Babri Masjid in December 1992: This even intensified debates about the nature of Indian nationalism and secularism. These developments are associated with the rise of the BJP and the politics of 'Hindutva'.

| v. The assassination of Rajiv Gandhi in May 1991: It led to a change in leadership of the Congress party. He was assassinated by a Sri Lankan Tamil linked to the LTTE. In the elections of 1991, Congress emerged as the single largest party. | | | |
