- 25. Contribution of Otto von Bismarck in German unification. Nationalist feelings started spreading amongst the middle class Germans, who in 1848, tried to unite different parts of German confederation into a nation state to have an elected parliamentarian government. However, this liberal movement was repressed by the combined forces of monarchy and military supported by Prussian landowners.

Prussian Chief Minister, Otto von Bismarck, took the responsibility of national unification with the help of Prussian army and bureaucracy. Under his leadership he fought three wars over seven years with Austria, Denmark and France. Prussia was victorious in all these wars and the process of unification of Germany was completed as a result of Prussia's victory over France.

Abanindranath Tagore painted his famous image of Bharat Mata. In subsequent years, the image of Bharat Mata acquired many different forms.

VandeMataram as a hymn to the motherland widely sung during the Swadeshi movement in Bengal.

Folklores and tales gave true picture of traditional culture that had been corrupted and damaged by outside forces. Therefore, nationalists began recording folk tales and legends.

As the national movement developed, nationalist leaders became more and more aware of icons and symbolism in unifying people and inspiring in them a feeling of nationalism. During the Swadeshi movement in Bengal, a tricolour flag was designed.

History was also important means of creating a feeling of nationalism that gave pride in the nation.

## 31. Division of powers

The Indian Constitution outlines the division of powers between the central government and state governments. This dual polity gives both levels of government their own spheres of authority.

Restructuring of center-state relations

The center-state relationship has been restructured to strengthen federalism. For example, if no single party gets a clear majority in the Lok Sabha, major national parties can form a government at the center by allying with regional parties.

Formation of linguistic states

After independence, the boundaries of some old states were changed to create new states based on linguistic characteristics.

Centralized amendment power

The power to amend the Constitution lies with the center under Article 368 and other provisions.
