and may hereafter be subject to the trust (hereinafter referred to as "the Trust Fund") for the objects and purposes hereinafter expressed with the powers and on the terms and conditions herein contained concerning the same.

2. The name of the Trust shall be "B. K. Birla Institution".

3. The objects for which the Trust Fund is established are education, relief of the poor, medical relief and advancement of other objects of General public utility in India and not involving the carrying on of any activity for profit and for such purposes :-

(1) To promote literature, education in different fields, science, fine arts (including dancing, music sculpture making, painting and drawing) and diffusion of useful knowledge.



(2) To support, establish, run, operate, maintain and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, lecture halls, museums and other establishments and institutions for the development of education and diffusion of knowledge in art, science, commerce, industry and agriculture.

(3) To promote for public benefit research and development.


(4) To grant scholarships, stipends, prizes, rewards and allowances or other financial assistance to students.

(5) To establish, maintain or grant aid or other financial assistance to hospitals, nursing homes, maternity homes, clinics, charitable dispensary, sanitarium and other establishments for giving medical relief to the poor, sick and infirm people.
